

**COMMISSION DECISION****of 30 August 2017****appointing the members of the group for technical advice on organic production and drawing up the pool list**

(2017/C 287/03)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Decision 2009/427/EC of 3 June 2009 establishing the expert group for technical advice on organic production <sup>(1)</sup>, and in particular Article 4(2) thereof,

Whereas:

- (1) By Decision 2009/427/EC the Commission has set up the expert group for technical advice on organic production ('the group').
- (2) Pursuant to Article 4(2) of Decision 2009/427/EC the Commission has adopted Decision 2010/C 262/03 <sup>(2)</sup> appointing the members of the group and drawing up a pool list of candidates for a period of application of that Decision ending on 31 December 2013. The application of that Decision has been extended until 31 December 2016.
- (3) By Commission Decision 2017/C 273/03 <sup>(3)</sup> the mandate of the members of the group provided for in Article 4(5) of Decision 2009/427/EC has been extended to a four-year term.
- (4) In line with Article 4(2) of Decision 2009/427/EC and with Commission's policy on transparency a call for applications for experts was published in the Register of Commission Expert Groups and Other Similar Entities. The dossiers submitted by applicants were evaluated and based on the evaluation a selection was made allowing to draw up a list of permanent members and a list for the pool of experts.
- (5) To complete the selection procedure the Commission has to appoint new members of the group for a four-year mandate and to draw up a new pool list of candidates,

HAS DECIDED AS FOLLOWS:

*Article 1*

The names of the permanent members of the expert group for technical advice on organic production are listed in Part A of the Annex.

The names of the members of the pool of candidates are listed in Part B of the Annex.

*Article 2*

This Decision shall enter into force on the day of its adoption and shall apply until 15 July 2021.
