Thank you for your e-mail of 21 February 2020, attached again among others in your e-mail of 27 February 2020 (Int. Ref. ARES(2020)1120720 and 1222360) asking for clarification with respect to the duration of conversion period in this phase of transition to the new Regulation (EU) No 2018/848¹.

To address the first case of your e-mail, concerning an elderberry orchard on which the conversion period began on February 2018, I can confirm your conclusion. Indeed, it is a perennial crop and in accordance with Article 36(1) of Regulation (EC) No 889/2008² as well as under point 1.7.1. of Part I of Annex II to Regulation (EU) No 2018/848, the organic production rules must have been applied **on the parcels** for at least three years before being able to first harvest organic products. Therefore, the period will end February 2021.

On the second case, where again the conversion period started on February 2018 but only in March there was the plantation of a new orchard of elderberry, again the parcel for a perennial crop must be in conversion for three years.

Finally, it is important to recall that under Article 17 of Regulation (EC) No 834/2007³ as well as under Article 10(2) of Regulation (EU) No 2018/848, the period of conversion starts at the earliest when the farmer has notified the activity to the competent authorities in accordance with Article 34(1). Hence, the activity as notified is important and if it was limited to previous arable crops or grassland on the parcel, the operator should have updated the notification as soon as possible.
