SUMMARY RECORD

Meeting of the COMMITTEE ON ORGANIC PRODUCTION

26-27 September 2018

Chair: Nathalie SAUZE-VANDEVYVER, Elena PANICHI

Delegations present: All Member States and the delegation of NO and IS were present.

A. PROPOSED MEASURES ON WHICH AN OPINION MAY BE REQUESTED

1. Draft Commission Implementing Regulation (EU) amending Regulation (EC) No 889/2008 laying down detailed rules for the implementation of Council Regulation No 837/2007 on organic production and labelling of organic products with regard to organic production, labelling and control (D055736)

Vote: Favourable opinion (in favour: 27 MS; abstained: 1 MS).

Discussion: Feedback mechanism, TBT notification and adoption procedure explained. Some MS made comments that will be taken into account; one MS asked for a clarification.

B. Points for information and/or discussion

1. EGTOP

Fertiliser and Food report published. New mandates for Food/Feed/wine group and Plant protection products group reviewed and endorsed.

If existing substances are reviewed (plant protection products, cleaning and disinfectants), Member States will be asked to submit supporting dossiers by November.

2. New draft document to discuss possible modifications of Annex I, VIII and VIIIa to Regulation (EC) No 889/2008

Document discussed.

Annex IX will be added to the document. Written comments requested by 20 October.

3. Flavouring

This item has been cancelled and will be reported to another COP.

4. Technical discussions on poultry, rabbits and quails production rules

COM presented the outcome of the technical discussions on poultry.

COM presented the outcome of the technical discussions of the expert sub groups on rabbits and quails.

MS were invited to send their written comments before 31 October 2018.

5. Other livestock production rules: pigs, cervine, bovine, equine, ovine

COM presented the main technical points on production rules for pigs.

COM presented the outcome of the technical discussions of the expert sub groups on cervine animals.

MS were invited to send their written comments before 31 October 2018.

No presentations and no discussions took place on bovine, equine or ovine animals.

6. Overview of the dossiers for the revision of Annex IX of Regulation (EC) No 889/2008 – Non organic agricultural ingredients

The EC informed that member states provided requests for 14 non-organic agricultural ingredients to be listed in the new Annex IX to Regulation (EC) No 889/2008. Member states may send until 12 October 2018 their comments, including assessment of the dossiers on availability of requested ingredients in their organic form.

7. Data Collection

This point was addressed under point 4 and 5 of the agenda. COM proposed to work on the information to be provided by Member States to the COM regarding databases and systems.

8. Letters of interpretation

The Commission brought the attention of MS to recent questions and replies concerning baby foods, steviol glycosides, use of CO2 in algae production, veterinary treatments in aquaculture.

9. Electronic certificate of inspection

The future developments of the IT tools were discussed.

10. Import regime (Regulation (EC) No 1235/2008)

The Commission informed the Committee of the next amendment of Regulation (EC) No 1235/2018.

16. Annual Reports- Template for Annex XIIIb of reg. 889/2008

The Commission presented the main problems regarding the timeliness and quality of content of annual reports.

The Commission also presented a new template for annex XIIIb of reg. 889/2008 in order to help Member States to provide the organic data of annual reports in a structured way.

The Commission will send to COP delegates a letter with the proposal.

17. AOB

- 1) BE: Silage additives (Ares(2018)4304141). Commission confirmed the necessity of the silage additives. The substances were accidentally deleted in 2012. Commission will see if how to solve this in next amendment.
- 2) NL: Co-formulants in cleaning and disinfecting agents (Annex VII, R889)

Commission informed that only for a few co-formulants of biocides there will be an evaluation. Commission has doubts if such an evaluation is possible for Annex VII

3) IT: Vitamin B2 and poultry feed

COM is aware of the situation. Both short and long term solutions need to be found by the sector.
