# SUMMARY RECORD

Meeting of the Committee on Organic Production

27 and 28 November 2019

Chair: Nathalie SAUZE-VANDEVYVER, Nicolas VERLET

Delegations present: All Member States. Norway was present as observer.

#### A. PROPOSED MEASURES ON WHICH AN OPINION MAY BE REQUESTED

A.1. Commission Implementing Regulation (EU) amending and correcting Regulation (EC) No 1235/2008 laying down detailed rules for implementation of Council Regulation (EC) No 834/2007 as regards the arrangements for imports of organic products from thirds countries -D064717/02

The outcome of the vote is positive. 25 Member States voted in favour, 1 against, 2 abstained.

#### **B.** POINTS FOR DISCUSSION AND/OR FOR INFORMATION

#### **B.1.** Implementing acts on trade

Article 45(4) of Regulation (EU) 2018/848 regarding the content of certificates and the procedure for issuance and verification.

Article 46(1) of Regulation (EU) 2018/848 regarding the future implementing act setting up the procedures leading to the recognition, and the withdrawal, of control authorities or control bodies competent to carry out controls and to issue organic certificates.

Article 46(7)(a) of Regulation (EU) 2018/848 regarding the criteria for the recognition and the withdrawal of the control authorities or the control bodies

## **B.2.** Guidelines on additional controls

Commission presented the updated version of the guidelines on additional controls following the contributions received from MS. The scope of the guidelines was discussed in terms of products and the number of samples, which should be taken by CBs and MS. The Commission gave explanations on sampling. Furthermore, it was discussed when the certificate of inspection should be signed. Following the discussion, the Commission made some changes to the guidelines and to the letter. The COP agreed to continue the additional controls.

The Commission presented an overview of the main consistency problems that emerged in the analysis OFIS cases.

Member States were debriefed on the OPSON VIII operation.

## B.6. Commission Implementing Regulation on labelling rules relative to Regulation (EU) 2018/848 on organic production and labelling of organic products and repealing Council Regulation (EC) 834/2007 – D065081/01

The Commission presented the future secondary legal provisions on labelling to the Member States. Several Member States highlighted the difficult situation for organic producers following the future prohibition to label certain feed as "may be used in organic production".

### B.7. Authorisation of non-organic ingredients

The Commission presented an overview of the national authorisations of nonorganic agricultural ingredients to the delegations, in order to analyse the current scenario. A second presentation explained the legal requirements which provide that the authorisation of non-organic agricultural ingredients at EU or at national level cannot circumvent the limitation of specific ingredients such as additives, micronutrients or colorant. Based on this and on the previous requests and comments from the Member States, the Commission presented a draft list of non-organic agricultural ingredients that would be authorised at EU level in January 2023.

### B.8. Review of the annex on cleaning and disinfectants (Annex VII)

Commission Implementing Regulation (EU) .../... of XXXX amending Regulation (EC) No 889/2008 laying down detailed rules for the implementation of Council Regulation (EC) No 834/2007 on organic production and labelling of organic products with regard to organic production, labelling and control - PLAN/2018/3293

The Commission presented the priority substances submitted by several Member States; the dossiers received and the way forward will be discussed with EGTOP in January.

### **B.9.** Letters of interpretation

The Commission brought the attention to the content of recent replies uploaded in CIRCA BC concerning: terpenes, corn starch used as fertiliser, EU bio logo use, rice starch used in mould, demand to share Commission replies, insects in organic production, microalgae production rules, feed material of mineral origin quartz. In addition, the Commission referred to the considerations received from MS on the use of conventional straw and underlined the responsibility of operators to limit off-farm inputs and avoid any potential contamination of parcels and productive cycle. On a question related to whether low energy electrons technique applied as disinfectant on seeds could be approved in organic production, the Commission recalled the general prohibition of using any ionizing radiation and need to deepen the nature of the mentioned technique through thorough EGTOP assessment.
